MMC

MEDICAL DIRECTOR

Jonathan Shultz reviewed several items:

- Issues have been identified with coverage agreement.
- COVID situation will either get better, worse or stay the same.
- St. Luke's ER is completed. Can accommodate 12 ambulances.
- Protocols state developing protocols; he is on the list to see them early. May be able to use them as is and add addendums if necessary.
- Letter printed in Duluth News that projected inaccuracies. He addressed the issues with the two individuals who wrote the letter as well as addressed the issues in a letter to the Duluth News.
- St. Luke's is being included in a nationwide study researching the value of antibody testing in health care workers including EMS. They will be looking for 50 volunteers, no compensation,

to participate. There will be several requirements including health care thru St. Luke's. He is providing email contact information for service directors. Email from Whiteside Research Institute may be passed on to others in your services who may wish to participate. He is also compiling a list if you are interested.
