During COVID many providers were lost. Concern that we are killing our own people. Reach out to legislators and newspapers to bring attention to the need for change.

CURRICULUM/HOURS PROPOSED – Lengthy discussion related to proposed changes/increase in hours required for EMR and EMT:

- EMR currently 50 to 90; proposed 108 hours
- EMT currently 180; proposed 288 hours
 - EMT required to take EMR before entry into EMT class for a total of 288 hours.

Strong consensus that adding hours will be detrimental. Jeff Byerhof and Jan Victorson will work on letter be forwarded as appropriate.

MARENGO AMBULANCE – EMT Service, currently licensed as a transport servive with the state, moving to EMR as they are unable to get people.
