You can use your cell phone hot spot.** **When requesting a helicopter make sure you give the name of the helicopter you want. You need to do the same when requesting an intercept with Mayo or Ashland.**

Training Report- WITC has normal Fall and Spring classes.

Old Business- Power cot installed. Please stop by the hall and check it out. Red switch at foot of cot to start rolling cot from rig. The back step does not need to be up. There are several led lights that will need to be replaced on light bar. Shirts are in, Gus your shirt will be at the hall soon.
